3. DESCRIPTION

ROBERTS 3085 Multipurpose is a high performance commercial-grade adhesive developed for the direct glue installation of most commercial carpets and can be used with felt-backed sheet vinyl flooring. It offers great adjustability time and once dry, a very strong bond to hold pattern carpets in place.

Uses

For adhering carpet, felt-backed sheet vinyl and unfinished cork underlayment.

Carpet Backings – Polypropylene (ActionBac®), woven, urethane foam (Enhancer™), polyurethane laminate (LifeSpan®), Axminster, Wilton, hot melt, latex unitary, needle-punch, sponge-rubber, jute, and latex-foam.

1/8" x 1/8" x 1/16"

Flooring: Carpet (polypropylene; woven) Coverage: 90-110 ft² per gallon

1/16" x 1/16" x 3/32"

Flooring: Felt-Backed Sheet Vinyl Coverage: 160-180 ft² per gallon

1/16" x 1/16" x 1/16"

Flooring: Felt-Backed Sheet Vinyl Coverage: 170-190 ft² per gallon

*The trowel notches referenced are those typically recommended for the type of flooring being installed and are shown as a guide. Consult flooring manufacturer for their specific trowel recommendations.

Substrates

Concrete, APA rated plywood, vinyl composition tile (free of wax) and terrazzo.

Limitations

- Do not use this adhesive for pure vinyl or vinyl-backed products.
- Ensure adequate ventilation during flooring installation.
- Not recommended for cork that will be installed as the final flooring surface.
- Not recommended for cork underlayment when used for wood flooring installations. When installing wood flooring, use ROBERTS 1407 to adhere cork underlayment to substrate.

5. INSTRUCTIONS

Preparation

Subfloors must be structurally sound, dry, smooth, flat (\leq 3/16" within 10'), level and free of excess moisture/alkali and all substances (oil, wax, grease, paint, oil based sealers, adhesive residue, etc.) that may inhibit the bond of the adhesive or the performance of the flooring or its installation.

All substrate cracks, chips, holes, joints, high spots and irregularities must be adequately repaired. Expansion or other moving joints must not be filled or covered with flooring. Patching compounds must be suitable for the use application, cement based and polymer-modified, and applied according to the manufacturer's instructions.

Existing vinyl composition tile (VCT) must be limited to one layer and well bonded. Installation over VCT is recommended for residential or light commercial traffic only. Remove all wax, floor finishes, dirt and contaminants that may interfere with the bond. Ensure manufacturer of flooring recommends installation of their product over VCT before proceeding.

Installation

This product is ready to use and does not require mixing. Materials and area temperature must be between 65–95°F with a maximum RH of 65% for 48 hours before and during installation as well as for 72 hours afterward. Large temperature or humidity increases or decreases can affect the flooring and performance of the installation. Lift a corner periodically to ensure 100% coverage of adhesive to the flooring backing and the substrate to ensure a void free bond.

Spread adhesive uniformly. Adhesive ridges should be of sufficient height to achieve full coverage of the substrate and the deepest recesses in the back of the flooring material.

Place flooring into the adhesive while the adhesive is still fresh. The amount of time in which you have to place the flooring will vary with temperature and humidity.

Curing

Up to 24 hours. High temperature and low humidity will cause the adhesive to cure faster.

After installation, restrict foot traffic and moving of heavy objects for 24–48 hours to allow adhesive to cure properly. Premature traffic can cause installation failure.

Clean-up

Fresh adhesive – warm soapy water.

 $\it Dried\ adhesive-$ use mineral spirits sparingly with a clean, white cotton cloth. DO NOT POUR DIRECTLY ONTO FLOORING.
