3. DESCRIPTION

ROBERTS 8415 is a solvent-based commercial-grade adhesive developed to seam most types of carpet and to prevent edge raveling. May also be used to repair bubbles in installations.

Uses

For seaming carpet edges and to prevent edge raveling on polypropylene, jute, urethane latex and unitary carpets.

This product is not recommended for seaming vinyl flooring.

5. INSTRUCTIONS

Installation

Ensure substrate, carpet and adhesive are fully acclimated prior to installation at the same temperature and humidity level expected during normal use (between 65°F and 95°F with a relative humidity (RH) of no greater than 65%). Large temperature or humidity increases or decreases can affect the flooring and performance of the installation.

Prepare /cut carpet edges according to manufacturer's recommendations. Apply a 1/8" bead of adhesive to one side of the carpet along the backing and where the face yarns enter the backing (not the cushion). Smooth out any excess adhesive. Join the carpet seams while the sealer is still wet.

Clean-up

Fresh and dried adhesive – use mineral spirits sparingly with a clean, white cotton cloth. DO NOT POUR DIRECTLY ONTO FLOORING.
