3. DESCRIPTION

ROBERTS 3000 Multipurpose is a contract-grade adhesive formulated for the installation of most types of commercial carpet and felt-backed sheet vinyl. Formulated with a longer open time for optimal positioning of sheet flooring, plus develops tack for the installation of rigid-backed carpets.

Substrates

Concrete, APA rated plywood, oriented strand board (OSB) and terrazzo.

- Do not use this adhesive for pure vinyl or vinyl-backed products.

5. INSTRUCTIONS

Preparation

Subfloors must be structurally sound, dry, smooth, flat (\leq 3/16" within 10'), level and free of excess moisture/alkali and all substances (oil, wax, grease, paint, oil based sealers, adhesive residue, etc.) that may inhibit the bond of the adhesive or the performance of the flooring or its installation.

Ensure the appropriate flatness/smoothness to prevent accelerated wear or "show through" (telegraphing).

All substrate cracks, chips, holes, joints, high spots and irregularities must be adequately repaired. Expansion or other moving joints must not be filled or covered with flooring. Patching compounds must be suitable for the use application, cement based and polymer-modified, and applied according to the manufacturer's instructions.

Refer to ASTM 710 Standard Practice for Preparing Concrete Floors.

Wood – Subflooring, such as APA underlayment grade plywood, hardwood, oriented strand board (lightly sanded), or other materials, must be flooring grade and installed to the manufacturer's specifications with adequate ventilation and moisture protection. Ensure wood substrates have a minimum 18" crawl space with adequate ventilation and moisture barrier protection. Refer to ASTM F1482 Standard Practice for Installation and Preparation of Panel Type Underlayments to Receive Resilient Flooring.

Refer to CRI Carpet Installation Standards, available at www.carpet-rug.org.

Installation

Materials and area temperature must be between 65-95°F with a maximum RH of 65% for 48 hours before and during installation as well as for 72 hours afterward. Large temperature or humidity increases or decreases can affect the flooring and performance of the installation. Lift a corner periodically to ensure 100% coverage of adhesive to the floor backing and the substrate to ensure a void free bond. If the adhesive is not transferring to the backing of the underlayment remove adhesive and reapply.

Spread adhesive uniformly. Allow up to 45 minutes of open time before you place your flooring into the adhesive. Adhesive ridges should be of sufficient height to achieve full coverage of the substrate and the back of the flooring. Place flooring into the adhesive while the adhesive is still fresh.

Within the 65 minute working time, place flooring into the adhesive while the adhesive is still fresh and transfers readily to the flooring backing. The amount of open time and time in which you have time to place the flooring will vary with temperature and humidity. The higher the temperature and the lower the humidity the faster the adhesive will set.

Curing

Up to 24 hours. High temperature and low humidity will cause the adhesive to cure faster.

After installation, restrict foot traffic and moving of heavy objects for 24-48 hours to allow adhesive to cure properly. Premature traffic can cause installation failure.

Clean-up

Fresh adhesive - warm soapy water.

Dried adhesive – use mineral spirits sparingly with a clean, white cotton cloth. DO NOT POUR DIRECTLY ONTO FLOORING.
