With its easy application and clean-up, this durable bonding seam sealer is used with fiberglass-back, felt-back, heterogeneous and linoleum sheets goods. Not for use with LVT / LVP or peel and stick flooring.

#### Uses

For interior use only. Used to seal seams for fiberglass-back, felt-back, heterogeneous and linoleum sheets goods. Residential and light commercial installation.

### Coverage

1/8" bead, approximately 144 lineal feet per 8 oz bottle.

#### Limitations

- · For interior installations only.
- Not for use on degraded / ripped / rolled seams, or for use as gap filler.
- Not recommended for health care installations where an aseptic environment is necessary. Heat-welded seams are recommended for those types of applications.
- Materials and area temperature must be between 18-35°C/65-95°F with a maximum RH of 65% for 48 hours before and during installation as well as for 72 hours afterward.
- · Ensure adequate ventilation during flooring installation.

#### 5. INSTRUCTIONS

# Installation

Prepare floor covering seams according to manufacturer's instructions. Once the seam is ready to be joined, Apply a 1/8" bead of adhesive along one entire edge of the sheet vinyl. Join the seam edges together. Wipe off excess sealer with a clean, damp cloth. Use a hand roller (or wallpaper seam roller) to secure the seam. Excess seam sealer may squeeze from the seam. Immediately clean seam again with a damp cloth and dry. Protect the seam, and allow to cure for 2 hours. Full cure - allow approximately 6 hours. Do not roll heavy furniture or appliance over the newly created seam for 24 hours.

Working Time: Up to 15 minutes

Curing

Up to 2-6 hours.

#### Clean-up

Fresh adhesive – warm, soapy water.

Dried adhesive – mineral spirits (sparingly) on a clean, cotton cloth. DO NOT POUR DIRECTLY ONTO FLOORING.
